PERSONAL GUARANTEE

Such withdrawal shall not affect any Guarantee Obligation created through the date thirty (30) days after said withdrawal is received. The undersigned hereby agree(s) to pay any and all of said sums, together with any legal and other costs, including attorney's fees, of enforcing the agreement contained herein both as against the Customer and the undersigned. This agreement is a Massachusetts contract and shall be interpreted under the laws of said Commonwealth and shall be effective immediately. This agreement is binding upon each of the undersigned guarantors, his or her administrators, executors, heirs, and assigns.

Each of the undersigned guarantors hereby authorizes Boston Cedar & Millwork, to investigate such guarantor's credit-worthiness as Boston Cedar & Millwork deems necessary, including, but not limited to, obtaining a consumer credit report on such guarantor for the purpose of evaluating the credit worthiness of such guarantor, in connection with an application for business credit, all as allowed by the Federal Fair Credit Reporting Act and applicable state law.
